II. TMC Police and Security Campus Update & Discussion – William McKeon & Carey Drayton, TMC

- Bill McKeon, TMC provided updates on the new TMC police and security system. Carey Drayton, will be observing and giving suggestions to the TMC to build the security system to be the strongest and provide the best services to the entire TMC campus.
- The goal to approach the changes in an environmental way, this will allow for opportunity for security and police teams across the TMC to join together. During the discussions, McKeon opened the floor to allow teams to provide observations and suggestions to the group. These included:
 - Streamline the communication among all institutions. Currently, the team does weekly radio check – ins. Not all institutions participate in this or know the accurate channel.
 - Coordinate camera control and locations. This will ensure that cameras displayed around campus are not covering the same place and we are receiving the maximum amount of surface area footage.
 - Questions were brought up and the accessibility with the cameras over the traffic lights. The council would like to look into seeing if the city of Houston would allow our security team to regulate and film from these areas.
 - Traffic control throughout campus. All teams regulate traffic in their own designated areas. Moving forward, the teams would like to share information to make traffic control easy and less painless for visitors and employees.
